## METHODS AND PURPOSES OF DATA PROCESSING

1. We would like to inform you that data will be processed with the aid of the following means:

- Electronic

## LEGAL BASIS

2) The legal basis on which the processing for common data is based, according to Art. 6 of the GDPR Regulation, is:

- Legitimate interest.

## CATEGORIES OF RECIPIENTS

3) The Personal Data may be brought to the attention of employees or collaborators of the Data Controller who, operating under the latter's direct authority, process data and are appointed as data controllers or processors pursuant to articles 24-29 of the European Reg. 2016/679 or system administrators and who will receive appropriate operational instructions from the Data Controller in this regard; the same will take place - by the Managers appointed by the Data Controller - towards the employees or collaborators of the Managers. The Personal Data may also be brought to the attention of the Managers, appointed by the Data Controller, as third-party companies or other subjects (by way of example but not limited to the subjects who are entrusted with assistance activities, IT service providers, managers and / or developers of websites or applications contained therein, operators of electronic platforms The complete and updated list of the Companies is available upon request to Compagnia Sali CIS Spa.

## MINOR

4) The site contains almost no information aimed directly at minors. Minors must not provide information or personal data.

## RETENTION PERIOD

5) Mandatory data for contractual and accounting purposes are kept for the time necessary to fulfil the commercial and accounting commitments.

The data retention period is: Data will be processed for as long as necessary to pursue the current commercial relationship and for the next ten years from their acquisition date.

## **RIGHTS OF THE DATA SUBJECT**

6) Pursuant to European Regulation 679/2016 (GDPR) and national legislation, in accordance with the procedures and within the limits established by current legislation, the interested party may exercise the following rights:

- Request confirmation of the existence of personal data concerning him/her (right of access);
- To know its origin;
- Receive intelligible communications;
- To have information about the criteria, the methods, and the purposes of the processing;
- Request the updating, rectification, integration, deletion, transformation into anonymous form and blocking of data processed in violation of the law, including those no longer necessary for achieving the purposes for which they were collected;
- Right of limitation and / or opposition to the processing of data concerning him;
- Right of revocation;
- Right to data portability;
- In cases of consent-based processing, to receive from a data processor the personal data provided to the Data Controller in a structured and readable form, in a format commonly available on electronic devices;
- Right to file a complaint with the Supervisory Authority.
